The University had applied for 12B status to the UGC on 22/7/2022. A five member Expert Committee conducted the virtual inspection on 23-24 February 2024. Further compliance in respect of faculty is required to be submitted vide mail received from UGC dated 10/6/2024.

The NIRF has been introduced by the MoE-GoI for the Open Universities from the year 2022-23. Accordingly, all the relevant data were submitted by the University through the dedicated portal on 7th March 2024. The result is yet to be published.
