Women's Day Celebration, 2025 with focus on the 10th Anniversary of the 'Beti Bachao, Beti Padhao' campaign

Objectives of the programme:

The "Beti Bachao Beti Padhao" (BBBP) campaign, launched by the Government of India, aims to address the declining child sex ratio and promote the education of girls. It was launched on 22 January, 2015 and is celebrating its 10th anniversary. In this connects the Internal complaints Committee, ICC resolved to celebrate Women's Day with focus on this scheme in collaboration with two community-based organisations who have worked on BBBP and other female welfare-oriented themes. The objectives of ICC, NSOU in organising the programme was as follows:

Raise Awareness: Educate participants about gender discrimination and the importance of the "Beti Bachao Beti Padhao" initiative.

Promote Gender Equality: Encourage a mindset of equality and respect towards girls and women.

Empower Girls: Provide information on rights and opportunities available to girls in education, health, and career development.

Community Engagement: Mobilize community members to actively support the welfare and education of girls.

Actionable Solutions: Develop a concrete action plan to address challenges faced by girls in accessing education and healthcare.

The first two phases of the programme were held by Nari o Sishu Kalyan Kendra and Seva Kendra. The ICC members attended both the programmes.

> Programme by Seva Kendra and ICC, NSOU:

On 18 February, Seva Kendra organised street plays at Motijheel located under Ward no 56 of Kolkata Municipal Corporation and Khanaberia located under Wards no 58 of Kolkata Municipal Corporation commemorating the tenth year of "Beti Bachao Beti Padhao" Campaign. The programme was held in the two slums from 11 am to 5 pm and there were approximately 120 participants. Through this initiative, attempts were made towards generating awareness and developing progressive mindsets among members of disadvantageous communities for prevention and responding to incidences of gender based social maladies like female feticide, child marriage, domestic violence, gender-based discrimination and exclusion of girl child from avenues of development.



These street plays were facilitated by staff members of Seva Kendra Calcutta and were screened at public spaces with substantial footfall. In the context of this initiative active participation was ensured on the part of community level stakeholders like senior level functionaries of CSOs and CBOs like youth clubs, ICDS functionaries, frontline health workers and opinion leaders besides members of the local communities mainly consisting of children including adolescent girls, youth and women. The script for this play was formulated by Mr. Subhabrata Acharya, Field Coordinator at Seva Kendra Calcutta. This play was focuses around the story of a girl child who was a victim of child marriage as she was married to a young boy at a very early age. Like any other child bride in contemporary traditional Indian society, the girl in her marital role had to be at the receiving side of the gender-based violence, abuse and exploitation being triggered by patriarchal mindset.

Despite getting support from her husband, the girl had to face tremendous hardships at the hands of her in-laws and relatives in terms of deprivation from basic necessities of life, neglect and alienation from participating in the decision-making process at her family. She was also not allowed to have any say in the decision-making process that directly affect her including decisions relating to pregnancy and acceptance of a newborn based on gender lines. Despite repeated attempts, she along with her husband was not able to convince her family to have institutional delivery. Owing to her early age, risk and complications associated with teenage pregnancy and non-institutional delivery, the main character of this play succumbed to such risk factors and passed away while giving birth to a girl child. The next phase of this play was an illustration with regard to the kind of struggle of being encountered by the child at her family and societal level. Since



her birth, the child had to face rejection with her family. However, with strong self-determination and support from her father, the child finally succeeded in not only developing a respectable career as being a teacher of a government aided Higher Secondary School but also establishing an identity of her own regardless of gender affinity. As a part of this play, dissemination of critical information relating to important gender based social problems like female feticide and selective sex selection, child marriage, human trafficking, gender based social exclusion and violence was ensured with a focus on its nature, magnitude, casual factors and impact.

As a part of this campaign, two shows have already been organized at two



locations namely Motijheel and Khanaberia. At Motijheel active participation was ensured on the part of more than 50 individuals mainly consisting of community level stakeholders and members of the local population including adolescent girls and women. On the other hand, more than 70 individuals mainly consisting of functionaries from the local youth

clubs, frontline health workers, school teachers, members of community level structures like Community Action Groups, Women's Groups, Opinion leaders and female members of the local ragpicker community were present during the performance of the street play at Khanaberia. In fact, during the event at Khanaberia, active participation was also ensured on the part of Prof. Ritu Mathur Mitra, Presiding Officer, ICC, NSOU.



In her speech, Prof. Mathur Mitra presented a brief illustration about various dimensions of gender-based violence in India with an emphasis on its nature, magnitude, casual factors and impact.

Towards the concluding part of her speech, Prof Mathur Mitra gave a brief elaboration about important initiatives that has been initiated by the government in terms of policy framework, schemes and campaigns that focus on prevention as well as redressal of incidences relating to gender-based violence and discrimination.

At the organizational level, Seva Kendra Calcutta have planned for continuing this campaign as a perennial initiative. As par this plan, the organization will organize at least one such street plays every month in most of habitations being covered under its programmatic intervention.



Programme by Nari o Sishu Kalyan Kendra, Bauria, Howrah and ICC, NSOU:

The ICC NSOU celebrated a programme at Nari o Sishu Kalyan Kendra, Bauria, Howrah on 18/02/2025 for celebrating Women's Day, 2025 with focus on the 10th Anniversary of 'Beti bachao, beti padhao' campaign. Mrs Rahima Khatun, Secretary of Nari o Sishu Kalyan Kendra extended a warm welcome to, Dr Kasturi Sinha Ghosh and Mrs Suchismita Chatterjee, the Members of ICC, NSOU. The programme begun from 2:00 PM, and a total of 50 participants, from within the community, mostly women and adolescent girls attended the programme.

Mrs Rahima Khatun, in her inaugural speech invited the participants, and said explained the objective of the programme to the participants. Mrs Rahima Khatun inspired the girls and women to be aware of their basic rights and be sensitive to each other's feelings. She encouraged the participants to share their ideas.



Dr Kasturi Sinha Ghosh, Member ICC NSOU, discussed about the Beti Bachao Beti Padhao campaign and talked about how girls in our society are often deprived of their basic child rights. Education is one such rights which must be ensured for each and every child of our community irrespective of their caste, creed or gender. We have to plan strategies to see that we are creating a societal structure where no one of is marginalized. Mrs Suchismita Chatterjee expressed that she was overwhelmed to see the participants and was hopeful that the programmes shall be a great success.





The young girls performed dance, dramas and recited poems all depicting ideas that girls have right to lead a life with respect and dignity. They should never be discriminated against boys. Theere was an interactive session in which all participated quite enthusiastically and following points were raised-

- ✓ Women are Human Beings and have right to lead a dignified life
- ✓ They must have their basic Human Rights of Education, employment, recreation and also participate in politics.
- ✓ They must not feel shy to talk about their problems and must participate in all developmental activities.

The programme was concluded at 4:30 Pm with a vote of thanks by the Honb'le President of Nari o Shishu Kalyan Kendra.





> Programme by ICC, NSOU at NSOU Headquarters:

The Internal Complaints Committee (ICC) of Netaji Subhas Open University (NSOU) successfully organized a grand event celebrating Women's Day 2025, marking the 10th anniversary of the 'Beti Bachao, Beti Padhao' campaign. Inaugural Session

Welcome Address

Professor Ritu Mathur Mitra, the Presiding Officer of the Internal Complaints Committee (ICC), delivered a compelling and insightful welcome address, setting

the tone for the Women's Day celebration at Netaji Subhas Open University (NSOU). She recalled her recent visits to Seva Kendra, which came up in the lecture as a remarkable instance of how extension programmes bridge academic theory with practical interventions. These visits, undertaken as part of NSOU's outreach initiatives, allowed her to witness firsthand the resilience of women striving for independence, dignity, and equality.

She shared her reflections on the inspirational work being done at Seva Kendra, where women from underprivileged backgrounds are given the tools and resources to become self-reliant. She spoke passionately about the significance of economic independence for women, emphasizing that true empowerment is not merely about policy formulations or academic discussions but about tangible changes in the lives of real individuals. Seva Kendra's initiatives—ranging from skill development workshops to micro-financing support—demonstrate that when women are given the opportunity to lead, entire communities benefit from their progress. Professor Mathur Mitra commended the organization's commitment to fostering a self-reliant society rooted in social harmony, justice, and respect for human dignity.

Her address was imbued with a strong call to action: the need for continuous engagement, not just through institutional policies but also through participatory involvement in grassroots movements. She encouraged students,

faculty, and community members to view gender justice as a collective responsibility—one that requires active involvement, open dialogue, and unwavering dedication. With an optimistic outlook, she expressed confidence that through sustained collaborations between academic institutions and civil society organizations, the vision of a gender-equal world can be realized.

In conclusion, Professor Mathur Mitra reiterated her faith in the transformative power of education, outreach, and advocacy in reshaping gender narratives. She urged all present to take inspiration from the stories of resilience and empowerment shared during the event and to commit themselves to being allies in the movement for women's rights. With her powerful and empathetic words, she set the stage for the day's discussions, reinforcing the idea that women's empowerment is not just an institutional goal but a societal imperative that demands persistent and collective effort.

Introduction of the Theme

She concluded by advocating for enhanced policy interventions, community-driven initiatives, and a stronger support system for girls, ensuring that the momentum generated by the campaign does not wane but continues to drive meaningful change.

Session I

Following the inaugural session, the event progressed into insightful discussions led by representatives from Nari o Sishu Kalyan Kendra (NOSKK) and Seva Kendra.

1. Presentation by Nari o Sishu Kalyan Kendra

Ms. Nargis Parvin, representing NOSKK, delivered a thought-provoking speech on the organization's mission to create a self-reliant and just society. She articulated NOSKK's vision of a society free from patriarchal oppression, where individuals can participate in a decentralized political and economic framework. She outlined their various initiatives, including forming self-help groups, enhancing knowledge and skills, and promoting gender equality in education, health, and economic spheres.

2. Insights from Seva Kendra

He highlighted various vocational training programs initiated by Seva Kendra, including hands-on training in producing jaggery, confectioneries, cakes, and other small-scale food products. Furthermore, he shed light on the pressing issue of young girls eloping due to socio-economic vulnerabilities and how such situations often lead to their entrapment in human trafficking networks. Drawing from his extensive experience as a member of Child-line, he narrated real-life cases where timely intervention saved young girls from exploitative conditions. He elaborated on the need for strong institutional support systems, community awareness campaigns, and policy enforcement to combat trafficking effectively. His address was not only deeply informative but also emotionally compelling, urging all stakeholders to collaborate in creating a safer and more empowering environment for women and young girls.

The event successfully brought together academia, civil society, and stakeholders in a meaningful discourse on gender equity and women's empowerment, leaving an indelible impact on all attendees. The Women's Day Celebration 2025 at NSOU was not only a commemoration of achievements but also a reaffirmation of collective efforts towards a more inclusive future.

Session II- Empowering 'Betis'

This session began by a video show organised by the members of Seva Kendra. The video was a heartwarming recording of the street plays held in the slum areas to promote the Beti Bachao, Beti Padhao campaign. Sri Sukhendu Bank emphasised the significance of street plays as a successful tool for creating awareness about women's rights.

This was followed by a performance by the community girls of Nari o Shishu Kalyan Kendra, highlighting the plight of a girl deprived of education and by their families and the final realisation of the parents that they should have educated their girl so that she could overcome the hardships of life, look after her family in a better way by becoming financially independent.



ICC members led by Dr. Kasturi Sinha Roy organised a fun-filled talent hunt session for the visiting community guests and NSOU learners. Both girls and boys participated in the session geared at creating awareness for empowering girls

through hands on activities which included a Quiz Competition and a Poster competition on the theme 'Beti Bachao Beti Padhao'. The learners participated enthusiastically.





The winners were selected by external faculty. Prizes were awarded to the winners and all participants were given gifts by ICC members. The programme ended at on a happy note with all participants posing happily for photographs.
